



IV.

RESUME OF BUSINESS TRANSACTED DURING THE FIRST SESSION OF THE THIRTEENTH TRIPURA LEGISLATIVE ASSEMBLY

SUMMONS

In exercise of the powers conferred by clause (1) of Article 174 of the Constitution of India on 9th March, 2023 Shri Satyadeo Narain Arya, the Governor of Tripura summoned the 1st Session of the Thirteenth Tripura Legislative Assembly and Notification was accordingly issued.

I. DURATION OF THE SESSION

The 1st Session of the Thirteenth Tripura Legislative Assembly commenced from the 24th March, 2023 to 28th March, 2023 and the House was adjourned SINE-DIE by the Hon'ble Speaker on 28th March, 2023. In exercise of the powers conferred by sub clause (a) of clause (2) of Article 174 of the Constitution of India, the Session was subsequently prorogued by His Excellency the Governor of Tripura Shri Satyadeo Narain Arya, with effect from the 24th April, 2023.

SITTING OF THE ASSEMBLY

The Tripura Legislative Assembly met under Rule 16 (1) of the Rules of Procedure and Conduct of Business in the Tripura Legislative Assembly House for 3 (three) day's sitting during the period from the 24th March, 2023 to 28th March, 2023 and in terms of hour it sat for 16.50 hours only.

IV. ELECTION OF SPEAKER

HII.

On 24th March, 2023 the Hon'ble Speaker Pro-tem Shri Binoy Bhusan Das conducted election of the Speaker. 2 (two) nominations proposing the name of Shri Biswa Bandhu Sen, MLA and Shri Gopal Chandra Roy, MLA for election of Speaker were submitted. After the election was over, Shri Biswa Bandhu Sen was declared as elected by Ballot Votes as the Speaker of the 13th Tripura Legislative Assembly in accordance with the provision of Rule 9(5) of the Rules of Procedure and Conduct of Business in the Tripura Legislative Assembly.

ELECTION OF DEPUTY SPEAKER

On 28th March, 2023 the Hon'ble Speaker in the Chair announced the agenda for election of the Deputy Speaker in the newly constituted 13th Tripura Legislative Assembly.

Two nominations proposing the name of Shri Ram Prasad Paul, MLA for election of the Deputy Speaker were submitted.

As such, the Hon'ble Speaker declared Shri Ram Prasad Paul as elected for the post of Deputy Speaker under Rule 10(4) of the Rules of Procedure and Conduct of Business in Tripura Legislative Assembly without contest.

VI. GOVERNOR'S ADDRESS

v.

On 24th March, 2023 this being the 1st Session of this year, the Hon'ble Governor of Tripura Shri Satyadeo Narain Arya addressed the House at 12.00 noon on 24-03-2023 in pursuance of Article 174 of the Constitution of India. After departure of the Hon'ble Governor the House dispersed and reassembled after 15 minutes at 12.20 P.M.

MOTION FOR ELECTION OF ASSEMBLY COMMITTEES

On 24th March, 2023 the Hon'ble Speaker informed consequent upon the dissolution of the last Assembly all the Assembly Committees had automatically been dissolved. As this is the first Season after the General Election, in pursuance of Rule 202(i) of the Rules of Procedure and Conduct of Business in the Tripura Legislative Assembly, 5 (Five) Elected Committees namely, (i) Committee on Public Accounts, (ii) Committee on Estimates, (iii) Committee on Public Undertakings, (iv) Committee on Welfare of Scheduled Castes, OBCs & Minorities and (v) Committee on Welfare of Scheduled Tribes are to be elected by the House for the period ending 31st March, 2024.

The Hon'ble Speaker also allowed Hon'ble Chief Minister to moved a Motion for Constitution of these 5 (Five) Elected Committees under Rule 98(iv) of the Rules of Procedure and Conduct of Business in the Tripura Legislative Assembly.

Professor Dr. Shri Manik Saha, Hon'ble Chief Minister moved the Motion in pursuance of Rule 98(iv) of the Rules of Procedure and Conduct of Business in the Tripura Legislative Assembly that the House do proceed to elect 11 (eleven) Members each of the Committees namely, (i) Committee on Public Accounts, (ii) Committee on Estimates, (iii) Committee on Public Undertakings, (iv) Committee on Welfare of Scheduled Castes, OBCs & Minorities and (v) Committee on Welfare of Scheduled Tribes according to the principle of proportional representation by means of single transferable vote for the period ending 31st March, 2024 as required under Rule 202(i) of the Rules of Procedure and Conduct of Business in the Tripura Legislative Assembly.

Then, the Hon'ble Speaker put to Voice Vote.

The Motion was passed by the Voice Vote.
